## 531.2 SECURITY SERVICE CONTRACT

Diane Gauvin, Director General introduced the item with some background. Wai Bong Shum, Director of Facilities Management stated that on March 27, 2023, the AutoritØ des MarchØs Public(AMP) registered the company currently servicing the college's security needs, Service de SØcuritØ Neptune, on the list of compies inadmissible to public contracts. Consequently, our contract with Neptune will automatically be cancelled after 60 days. The college is required to source a new supplier or to obtain permission from the Treasury Board to continue with the current service provider.

Given the urgency of the situation, the college opted for a new supplier. The Treasury Board has granted an exceptional exemption for mutual agreement contracts for all public organizations in this situation, for a period of nine months.

In parallel, the Centre d'Acquisitions Gouvernementale(CAG) is currently undergoing preparatory work for a public call for tenders for security agency services. The new contract start date is slated for November 1, 2023.

The College is proposing to sign a new contract with Commissionnaires du QuØbec until we can join the group purchase.

It was moved by Alex McComber, seconded by Pelagia Nickotelopoulos, THAT THE BOARD OF GOVERNORS AUTHORIZES THE COLLEGE TO AWARD A CONTRACT BY MUTUAL AGREEMENT FOR SECURITY SERVICES TO "COMMISSIONNAIRES DU QUÉBEC", FROM APRIL 10, 2023 TO OCTOBER 31, 2023, IN THE AMOUNT OF \$585,000.00 EXCLUDING TAXES.

The motion was adopted unanimously.
